I am aware of risks and hazards connected with exercise and my child hereby elects to voluntarily participate in Exercise activities, knowing that the exercise and equipment may be dangerous to my child. - i. any injury or loss of life of any kind; or
- ii. any Loss (including damage) to any property; and
- iii. the provision of the Services or our use of the Deliverables infringing or allegedly infringing any Intellectual Property or other rights of any third party, (including in each case, consequential Loss) arising directly or indirectly out of or in connection with any act or omission (including negligence) of Urth Fitness or its Personnel (including subcontractors) in providing or failing to provide the Services.

**Personal Property:** I agree that any personal property I bring onto the premises of Urth Fitness, or any training area utilised for the conduct of Urth Fitness fitness training activities, I do so at my own risk sole risk.
